**Filling of a Vacancy Under Paragraph 13 (b) of Article 99 of the Constitution of  
The Democratic Socialist Republic of Sri Lanka**

WHEREAS, the Secretary General of Parliament has informed the Election Commission, under Section 64 (1) of the Parliamentary Elections Act, No. 1 of 1981, that a vacancy has occurred in the membership of the Ninth Parliament by reason of ceasing to be a Member of Parliament of Mr. Ahamed Zainulabdeen Nazeer, who was declared elected as a Member of Parliament for the Electoral District No. 12 - Batticaloa under Section 62 of the aforesaid Act;

And whereas the Returning Officer, for the Electoral District which returned the said member was directed by the Election Commission under Section 64(1) of the Parliamentary Elections Act, No. 1 of 1981 to fill this vacancy as provided for under paragraph 13 (b) of Article 99 of the Constitution;

And whereas, the said Returning Officer acting under Section 64(2) of the Parliamentary Elections Act, No. 1 of 1981 and in terms of paragraph 13 (b) of Article 99 of the Constitution has made a return in form "M" set out in the first Schedule to the aforesaid Act, to the effect that Mr. Ali Zahir Moulana Seiyad was declared elected as a Member of Parliament for the said Electoral District and has submitted the report to the Election Commission;
